



Laptop Policy Summary

Parent Responsibilities

Your child has been issued a Lenovo laptop computer to improve and personalize his/her education this year. It is essential that the following guidelines be followed to ensure the safe, efficient, and ethical operation of your child's computer.

- I will supervise my child's use of the laptop at home.
- I will discuss school policies and expectations regarding the use of the Internet at home and will supervise my student's use of the Internet.
- I will not attempt to repair the computer.
- I will report to the school any problems with the computer.
- I will not load or delete any software from the computer.
- I will make sure my student recharges the computer battery nightly.
- I will make sure my student brings the computer to school every day.
- I understand that misuse or inappropriate use as determined by school personnel may, and will, result in any and/or all of the following:
 - Student conference
 - Parent conference
 - Cancellation of access privileges and loss of computer privileges.
 - Any and all school disciplinary actions civil or criminal liability under applicable laws.

***I know that if my child comes to school without his or her computer I may be called to bring it to school.**

Laptop Policy Summary

Student Responsibilities

Your computer is an important learning tool and is for educational purposes only. In order to take your computer home each day, you must be willing to accept the following responsibilities:

- I will treat the computer with care by not dropping it, getting it wet, leaving it outdoors, defacing, or using it with food or drink nearby.
- I will not loan the computer to my friends or siblings; it will stay in my possession at all times.
- I will not load software from any media form onto the computer.
- I will not remove programs or files from the computer.
- I will follow the Guerin College Prep High School Acceptable Use Policy with the computer at home and at school.
- I will comply with all copyright laws.
- I will honor school policies and expectations at all times.
- I will not give personal information when using the Internet.
- I will not attempt to repair the computer.
- I will recharge the computer battery each night.
- I will bring the computer to school every day.

***I know that this computer is on loan to me. All school policies and procedures, Acceptable Use Policy and applicable laws must be followed. I understand that any violation could result in loss of computer use.**

SAMPLE: GUERIN PREP LEASE AGREEMENT

1. Guerin Prep (Lessor) hereby leases to Lessee the personal property described above, hereinafter referred to as the “unit.”
2. The lease shall commence on January 10, 2008, and provided lessee has successfully performed all lessee’s duties and obligations under the lease, shall terminate upon expiration on June 30, 2011.
3. The lessee shall pay the advance rental due under this lease on the date of the first tuition payment due for the school year. This shall be for a ten-month period.
4. The lessee acknowledges that lessor is leasing the “unit” to lessee “as is” without warranty, other than as provided by the manufacturer. Lessee hereby waives any claim lessee might have against lessor for any loss, damage or expanse caused by the unit.”
5. Lessee shall, at lessee’s expense, use, maintain, insure and keep the “unit” in good operating order in the manner for which it was designed and intended. Lessee shall not make any alterations or additions to the “unit” without the prior written consent of lessor.
6. Lessee shall not assign or in any way dispose of all or any part of his rights or obligations under this lease or enter into any sublease of all or any part of the “unit” without the prior written consent of lessor.
7. The “unit” is, and shall remain, the property of lessor, and lessee shall have no right, title or interest herein or thereto except as expressly set forth in the lease.
8. If lessee leaves Guerin Prep High School, all lease amounts shall be immediately due and lessee may retain “unit.” If lessee leaves Guerin Prep before the lease ends and elects not to pay the remainder of the lease, a \$200.00 cancellation fee will be charged.
9. If lessee violates any of the terms set forth herein, all amounts shall be immediately due and lessee may retain “unit,” or at the option of lessor, lessee may return the “unit” to lessor with payment of all amounts due as of the return date.
